PRIMARY CARE PROVIDER RESOURCES

Promote the adoption of the Care Provider Toolkit in primary care across the state of Washington.

EQUAL ACCESS TO HEALTHCARE INFORMATION

Ensure that all healthcare providers, regardless of their background, have equal access to healthcare information. This includes being mindful of addressing barriers to access, such as language barriers, geographic barriers, or socioeconomic barriers.

RESOURCES AND PROGRAMS FOR OPIOID USE DISORDER TREATMENT

Increase awareness of state programs and training opportunities to improve skills to address opioid use disorder.

BEHAVIORAL HEALTH INTEGRATION IN PRIMARY CARE

Foster awareness of resources in behavioral health for primary care providers, especially those in rural areas with limited access to specialists.

DynaMedex

DynaMedex provides the latest evidence-based clinical information to make complex decisions at the point of care for 45 medical specialties (see list below), nurse practitioners, and midwives. Personalized alerts allow clinicians to track practice-changing updates, study and guideline summaries, drug and device alerts, outbreak alerts, evidence updates, and clinical recommendations. DynaMedex adheres to the evidence-based medicine (EBM) fundamentals framework to carefully select clinical recommendations and define the evidence. Physicians, nurse practitioners, and midwives using DynaMed to inform and support their clinical decisions are eligible to earn continuing medical education (CME) credits and continuing education (CE) contact hours, respectively, for internet point of care (PoC) activities. Physicians in certain specialties may also be eligible to earn Part II Maintenance of Certification (MOC) points.
